#### **NOTICE INVITING TENDER**

Director, National Centre For Disease Control (NCDC), Government Of India, invites sealed bids under single bid system ie. Technical and Commercial are invited from registered firms for auction of old / obsolete / usedPREFABRICATED BSL-3 LAB on "As is where is basis"

#### A. General:

#### 2. Details of Bid:-

#### **B. Eligibility / Qualification Criteria:**

- a) The bidders shall have to provide services required at New Delhi/Delhi.
- b) The firm may enclose sufficient document regarding execution of government work order.

c) All bidders must enclose GST registration certificate along with the Tender Document

#### B. Period of Validity of Bid:-

The bid shall remain valid for 60 days after the date of bid opening. If any bidder withdraws his tender before the said period Director, NCDC shall, without prejudice to any other rights or remedy, be at liberty to forfeit the bid security.

#### D. General Terms and Conditions

- 1. The bidders may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for, as the items condition is on "As is where is basis "
- 2. The items shall be sold to the highest bidder (Taxes Inclusive).
- 3. The Earnest money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned within one month of the auction date, without any interest.
- 4. No items, once disposed to the successful bidders shall be taken back by O/o the Director, NCDC. Delhi.
- 5. The successful bidder has to make full balance payment in the form of Demand Draft in favour of Director, NCDC Delhi within 2(Two) days after confirmation, failing which the offer will be cancelled and EMD shall stand forfeited.
- 6. Earnest Money Deposited (EMD) of Rs. 20000/- (Rupees Twenty Thousand Only) must accompany with thequotation. This shall be in the form Demand Draft/ Pay order of any Nationalized / scheduled bank in favour of Director, NCDC, Delhi without which the tender shall be summarily rejected. No cheques Money order/cash shall be accepted. The EMD shall not attract any interest.

- 7. The successful bidders shall be required to lift all the items from the Disposal site to its premise within 2 (two) days after the payment of the quoted amount. On failure to do so, Director, NCDC, Delhi, shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder
- 8. The Total price should be inclusive of all Misc. charges like transportation, labour or any other expenses including Taxes.
- 9. Each page of tender document should be signed by the bidder(s).
- 10. Incomplete and unsigned quotation are liable to be rejected.
- 11. Total quotations price on letter head of the firm -Annexure A.
- 12. The detail list of items may be referred while submitting the bid (Annexure B). However, if there is any deviation in model /Make as per the list, then the actual model of the items will be final. No claim for this will be considered.

## E. Bidding Procedure:-

- a) Sealed bids shall be received, not later than 10:30 AM on date14.9.2020. No bids will be accepted after this date & time under any circumstances .This office will not be responsible for any Postal/courier delay and also for reasons beyond the control of this office.
- b) The bids will be opened on Pre- scheduled date, time & venue.
- c) All the bids must be accompanied by a security (EMD) of the amount of Rs. 20000/- Rupees Twenty Thousand Only) in form of Bank Draft/ Pay Order issued by any commercial bank in favour of Director NCDC, Delhi.
- d) All relevant rules and regulations of Government of India will be final and applicable & binding on all bidders

#### F. Submission of Bids:-

- a) The Bid Envelope shall be superscripted with the file number/ name in capital letters. The envelope shall be opened on the date of opening of tender. The bid security must be enclosed with the tender
- b) Silence or use of the word "Noted" against any of the Bid conditions shall mean bidder agrees to comply with that / those conditions of Bid.
- c) All prices and other information in this regard having a bearing on the price shall be written both in figures and words in the prescribed offer form.
- d) The bid should be submitted in the prescribed bid format given as prescribed in "Bidding Procedure" of this document. All columns of the bid form should be filled. Any additional information should be enclosed separately and referred to in the relevant column of the bid form. All relevant product literature must be enclosed with the bid.
- e) No bid can be modified subsequent to the deadline for submission.

### **G** Opening of Bids:

- a) The competent authority at NCDC will open the bids as per scheduled time, date and venue in the presence of the bidders representatives who choose to attend.
- b) The bidders representative who will be present shall sign in the designated register evidencing their attendance, In the event of the specific bid opening date being declared a holiday for NCDC, the bid shall be opened at the same time and location on the next working day.
- c) The bidders names, bid withdrawals, presence of bid security and such other details as the Institute at its discretion may consider appropriate, will be announced during the bid opening.
