


District wise disease alerts/outbreaks reported in the 9th week 2022 9th Week Map






Cases presented with weakness of lower limbs and myalgia. Two nasopharyngeal, two oropharyngeal and three blood samples were sent to Shree Krishna Hospital Karamsad Di Anand. Both the nasopharyngeal swabs were positive for (Epstein Bar Virus & Human Herpes Virus-7). District RRT visited the affected area. House to house surveillance for active cases was done. Health education was given.

Cases presented with weakness of lower limbs and myalgia. One blood sample was sent to SSG Hospital Vadodara and two water samples were sent WASMO Mahisagar. The blood sample showed no presence of organism. Both the water samples were found fit for drinking. District RRT visited the affected area. House to house surveillance for active cases was done. Health education was given.
GJ/MHS/2022/09/048	Gujarat	Mahesana	Food Poisoning	1268	00	05-03-22	05-03-22	Under Surveillance	Cases reported from Village Savala; SC Kansarakui; PHC Kansarakui; Block Visnagar; District Mahesana. Cases presented with vomiting and abdominal pain. 29 stool samples and vomitus sample were sent to GH Mehsana and GMERS Vadnagar. Food sample was sent to F&D Department. Result awaited. All the stool and vomitus samples showed no organism. District RRT investigated the outbreak. Symptomatic treatment was given to all the cases. Chlorine tablets were distributed. Health education was given regarding importance of safe drinking water and properly cooked food.

Cases presented with vomiting and dehydration. District RRT investigated the outbreak. Apparently, students had consumed food in the hostel mess. Symptomatic treatment was given to all the cases. Chlorine tablets were distributed. Health education was given regarding importance of safe drinking water, food hygiene and sanitation.
KL/ERN/2022/09/050	Kerala	Ernakulam	Acute Diarrheal Disease	21	00	24-02-22	07-03-22	Under Surveillance	Cases reported from Malippuram, PHC Nayarambalam, Nedungad, Ward 5. Cases presented with abdominal discomfort, abdominal pain, loose stools, vomiting, fever and head-ache. Two stool samples and five water samples were send to RPH lab for bacteriological test. Of these, four samples were found satisfactory and one showed non-fecal contamination. District RRT investigated the outbreak. Symptomatic treatment was given to all the cases. Chlorine tablets were distributed. Health education was given regarding importance of safe drinking water.

Cases presented with abdominal pain and loose stools. Five water samples were sent for lab investigations. Of these, four water samples were found unfit for consumption. Three stool samples were sent for lab testing. Of which, one sample showed presence of Enteropathogenic E.coli. District RRT investigated the case. Symptomatic treatment was given to all the cases. Chlorine tablets were distributed. Health education was given regarding importance of safe drinking water.

Cases presented with vomiting and loose stools. Food Sample was taken by Food & Drugs Department and result is still awaited. District RRT investigated the outbreak. People had apparently gathered for a birthday party and consumed food. Symptomatic treatment was given to all the cases. Chlorine tablets were distributed. Health education was given regarding importance of safe drinking water and properly cooked food.
TL/WRG/2022/09/053	Telangana	Hanumakonda	Food Poisoning	22	00	02-03-22	03-03-22	Under Control	Cases reported from MPPS Primary School, Village Sriramulapally, PHC Kamalapur, District Hanumakonda. Cases presented with vomiting and abdominal pain. Water samples were collected and sent to RWS. Results awaited. District RRT investigated the outbreak. Symptomatic treatment was given to all the cases. Chlorine tablets were distributed. Health education was given regarding importance of safe drinking water and properly cooked food.
WB/SPG/2022/09/054	West Bengal	South 24 Parganas	Acute Diarrheal Disease	21	00	23-02-22	23-02-22	Under Control	Cases reported from DHHD, DH Municipality, Ward No. 2. Cases presented with loose stools, fever, vomiting, and abdominal pain. Five rectal swabs were sent to Diamond Harbour Govt. Medical College and Hospital. No growth was found in any of the samples. District RRT investigated the outbreak. Symptomatic treatment was given to all the cases. Chlorine tablets were distributed. Health education was given regarding importance of safe drinking water and properly cooked food.

WB/NCP/2022/09/055	West Bengal	North 24 Parganas	Acute Diarrheal Disease	359	01	05-03-22	06-03-22	Under Surveillance	Cases reported from ward no 8,9,10,12,13, 14/ Halisahar Municipality/ District North 24 Parganas. Cases presented with loose stools and abdominal pain. The deceased case was a 36 years old female. Four water samples were sent to NICED for microbiological testing and four to PHE Water lab for chlorine test. Three stool samples were sent to the NICED. It was found that residual free chlorine level was <0.1 mg/L for four water samples. Results for water and stool samples from NICED are awaited. District RRT investigated the case. Food was discarded and hence was not collected. Symptomatic treatment was given to all the cases. Chlorine tablets were distributed. Health education was given regarding importance of safe drinking water.

Cases presented with fever and rashes. 4 blood samples were collected sent to the RIMS Ranchi for laboratory investigation. All the collected samples were found positive for Varicella Zoster Virus by IgM ELISA positive. Patients were treated symptomatically. District RRT investigated the outbreak. Heath education was provided to villagers regarding chickenpox.		

WB/HWR/2022/09/057	West Bengal	Howrah	Viral Hepatitis A	60	00	02-02-22	Under Surveillance	Cases reported from Bhujanga Dhar Lane, Satyasadhan Dhar Lane, Chasipara under Liluah Potuaparatua Para, HMC WARD 63, District Howrah. Cases presented with abdominal pain, jaundice and vomiting. Five water samples were collected from suspected taps and households and sent to NICED. No organism was found in any of the water samples. Seven blood samples were collected from patients with high bilirubin and high SGPT, SGOT and were sent to NICED. All blood samples tested positive for Hepatitis A by IgM ELISA and one sample was also found positive for Hepatitis E. District RRT investigated the outbreak. Symptomatic treatment was given to all the cases. Chlorine tablets and bleaching powder were distributed. Pipelines were also repaired. Health education was given regarding importance of safe drinking water, food hygiene and sanitation.
